SCHOLARSHIP TERMS AND CONDITIONS

Rennes School of Business reserves the right to withdraw the scholarship if the following terms and conditions are not respected. Scholarship applicants are required to:

1. Be accepted or registered as a full-time fee paying students for the coming cohort (September 2020).
2. Return a completed scholarship application file (form and supporting documents) to Rennes School of Business Admissions Office. Rennes School of Business reserves the right to withdraw the scholarship offer if the candidate has not formally accepted it.
3. Meet conditions attached to the academic programme as well as those specific to the scholarship.
4. Scholarships may not be differed to the following academic year.
5. Inform the Admissions Office of any other scholarship/sponsorship held. The scholarship may be adjusted and/or withdrawn if a full tuition scholarship has been awarded to the student from another institution.
7. Pay all outstanding tuition fees by given deadlines. Non-payment of fees may result in withdrawal of scholarship. In this case students, will be charged the outstanding balance.
8. Return scholarship amount (on a pro-rata basis) should they withdraw from their course before completion.
9. The final decision for scholarship award is made by the Scholarship Committee:
Changes in study programmes (course title, course transfers, suspension of study) must be approved by Rennes School of Business. Any changes made without the consent of Rennes School of Business can lead to a withdrawal of scholarship. In this case, full tuition will be charged.
